Terms and Conditions

Opening Orders - require a \$125 minimum purchase with a credit card or prepaid company check.

Reorders - require a \$50 minimum purchase with credit card, prepaid company check or approved net 30 terms. If you place less than the required \$50 minimum product in the shopping cart, you will not be able to checkout without meeting the minimum order amount.

Minimum Quantities - in general, the minimum quantity available for purchase per item is six. We may lower the minimum quantity to three for example for promotions. If you add an item to the shopping cart and your amount is under the minimum quantity, it will automatically change to the minimum purchase quantity required.

Order Changes - once an order is placed, changes cannot be made.

Restocking Fee - there will be a 20% restocking fee for returned items unless due to manufacturer defect or error.

Net 30 Accounts not current - requires bringing your account current prior to placing any more orders. Should this situation be an ongoing occurrence, the account will revert to prepayment for orders thereafter. NTI provides approved customers net 30 terms to assist you with extended payment. NTI cannot operate properly if we, in turn, are not paid timely. We appreciate your diligence in strictly adhering to the net 30 terms.

Finance Charges - accounts that are not current will accrue at 1.5% per month on each month's current balance.

Damages/Shortages - Any claims related to damages or shortages must be made within 5 business days from the shipping receipt of the products. The products must be in their original packaging for inspection and product replacement. NTI respects your time and understands that you expect your order to be right the first time. NTI doublechecks each order as well as uses scanning technology to ensure you receive the styles and quantities ordered. NTI also checks each product before shipping to you to ensure each meets NTI's high quality standards.

Resale Certificate - we are unable to withhold sales tax by law if a current resale certificate or sales tax license is not on file with Now That's Impressive. Please fax a current copy to us anytime at 859.781.7484.

Rush Orders - Now That's Impressive recognizes your need to have product when you need it so we will make every effort to accommodate rush orders without an additional NTI charge. We would, however, need to pass along any rush shipping charges to you for expediting the shipment of your order.

In the event, our production queue can not accommodate a particular rush order, we would advise of such and if it would take extreme measures to manage the exception, an NTI charge may be necessary but would be communicated up-front to you.

Shipping - Priority USPS shipping will apply to all domestic orders. International shipping is TBD.

International Stores - NTI's international store policy is in process. Please refer to the website for an update.

Online Stores - online (internet) stores may not sell below the Manufacturers Suggested Retail Pricing (also referred to as MSRP) for our products. Online stores must also agree NOT to sell the Now That's Impressive product on Ebay or other online auctions. **Pricing** - NTI may at any time, with or without notice, be required to change product pricing to accomodate current market conditions. NTI's goal is to keep product pricing at a level that is attractive to your customers while making it a profitable for your store.

Terms & Conditions - NTI may at any time, with or without notice, change any aspect of its wholesale terms. As your partner, NTI recognizes that significant changes impact your business and will make every effort to notify you of those types of changes.

All accounts are prepaid with credit card or company check until your credit application has been completed, reviewed and approved. If any indebtedness incurred pursuant to this request for credit is not paid in full when due, the undersigned agrees to pay all costs of collection, including reasonable attorney fees. Any balance so remaining unpaid shall bear interest at the lesser of 1.5% per month or the maximum rate permitted by applicable law, until paid in full.
